# First Aid Measures

Eye Contact

Flush eyes with large amounts of water, for at least 15 minutes, until irritation subsides. If irritation persists get medical attention.

#### Appropriate engineering controls

**Engineering Controls** Use general ventilation and use local exhaust, where possible, in confined or enclosed spaces.
